# Land Acknowledgement

#### Land and African Ancestral Acknowledgements

I would like to start by honouring the land that we are on, which has been the site of human activity since time immemorial. It is the traditional territories of the Huron-Wendat, Anishinabeg, the Chippewa, the Haudenosaunee Confederacy and most recently, The Mississaugas of the Credit River First Nations.

Ontario is covered by 46 treaties and other agreements, and is home to many Indigenous Nations from across Turtle Island, including the Inuit and the Metis. These treaties and other agreements, including the One Dish with One Spoon Wampum Belt Covenant, are agreements to peaceably share and care for the land and its resources. Other Indigenous Nations, Europeans, and newcomers, were invited into this covenant in the spirit of respect, peace, and friendship.

We mindful of broken covenants and we strive to make this right, with the land and with each other.

We are all **Treaty people**. Many of us, have come here as **settlers**, **immigrants**, **newcomers** in this generation or generations past. I would like to also acknowledge those of us who came here forcibly, particularly as a result of the **Trans-Atlantic Slave trade**. Therefore, I honour and pay tribute to the **ancestors of African Origin and Descent**.

- We will demonstrate fiscal responsibility and be accountable to patients and community.


- Together. we will apply a holistic. coordinated and integrated approach to planning for the population of West Toronto and collaborate towards the co-creation of the West Toronto OHT.

# Who can be a member of the WTOHT and what are their roles and responsibilities?



# Approach for the Steering Committee membership

- Fifteen (15) SC members on a staggered term of 2-3 years
  - In addition, Home and Community Care Support Services, Ontario Health and Toronto Public Health will be considered as <u>ex officio/non voting members</u> on the Steering Committee
  - WGs Chairs may be asked to attend the Steering committee meetings as ex officio/non voting members as needed
- General representation, not specifically sector representation
- All members defined on slide 5 are eligible to apply
- Process for selecting SC members needs to be transparent
  - Voting by WTOHT members




# Approach for the Steering Committee Membership




# Approach for the WTOHT Membership

#### Organizations representation at SC through a Call for membership




### Call for WTOHT members and SC members

#### One selection process with two-tiered approach for organizations

- Call for membership to update WTOHT members
  - Governance WG will act as the nominations committee for the WTOHT membership
- Call for Steering Committee members
  - Governance WG will review applications and confirm that applicants meet criteria
  - Vote by WTOHT members to select SC members

#### •Mandated organizations seats:

- Acute Care seat is open to all acute care hospitals who meet the criteria for membership and apply to become a SC member
- SPO seat is open to all SPOs who meet the criteria for membership and apply to become a SC member
- All members will sign the existing CDMA until review and revisions are completed



### Criteria to become a WTOHT member

Membership is open to all organizations that:

- 1. Commit to the <u>vision</u>, <u>guiding principles</u> and <u>Patient</u>, <u>Family and Caregiver Declaration of Values</u> of the WTOHT;
- 2. Deliver health or social services to our attributed population;
- 3. Willingness to commit resources to achieve the vision and goals of the WTOHT (e.g. time, money, expertise, staff, space, communications);
- 4. Agree to work as a collective member of the WTOHT; and
- 5. Sign the Collaborative Decision Making Agreement (CDMA).


Individual Patients, Caregivers and Families and Physicians are eligible to participate through the WTOHT Partners for Better Care Council and WTOHT Physician Association (in development)

# Criteria to become a WTOHT Steering Committee (SC) member

#### In addition to the membership considerations, additional criteria for SC member organizations:

- Organizations demonstrate commitment to health equity ( for e.g. health equity framework, Health Equity Impact Assessment Tool (HEIA));
- Organizations' work impact the current population working groups (COPD, Frail Seniors, MHA) and other high priority/vulnerable population;
- Organizations focus on clients' outcomes and accountable to what is important to their clients and the attributed population (community);
- Organizations have a willingness to be accountable for the shared OHT goals and objectives and responsible to the entire WTOHT members and community;
- Organizations commit to participate, provide and report data for the collaborative Quality Improvement Plans (cQIP) indicators;
- Organizations commit to the staggered term (2-3 years) representation at the SC;
- Organizations commit to transparency including conflict of interests with WTOHT and potential financial benefits;
- Organizations commit to 10 hours per month for WTOHT work (at SC and other forums of the WTOHT); and
- Organizations are ambassadors of the WTOHT.

# **Application Process**

- Any organization can apply to become a member and a SC member of the WTOHT as long as they meet the criteria defined (slides 10 and 11)
- Interested organizations will complete the <u>application form</u> by April 8, 2022

# **Questions and Answers**

### Q&A

- Can any organization become a member of the WTOHT?
  - Yes, any organization can apply to become a member of the WTOHT as long as they meet the criteria of membership (defined on slide 10 in this presentation deck)
- Can my organization apply to become a member of WTOHT, if I am already a member of another OHT?
  - Yes, you will complete the application form and under Part A, Question 7, you will indicate whether you are a member of another OHTs or not
- Can you provide some examples of how organizations can show their willingness to commit resources to achieve the vision and goals of the WTOHT esp. money?
  - Any monetary contribution will be voluntary for WTOHT members. Examples include money for one-time expenses. At this point, there is no ask for any financial contribution from members to be part of the WTOHT. The WTOHT is funded for implementation of activities at this point.
- How can I apply to become a member?
  - You will complete Part A of the application form only.

### Q&A

- How can I apply to become a Steering Committee member?
  - You will complete question 10 and will proceed to the Part B: Steering Committee Nomination, where you will have an additional eight (8) questions to respond.
- •How will the Steering Committee (SC) members be selected?
  - The Governance WG will review all applications for general membership and SC membership and will provide a list of organizations applying for SC members as well as a copy of their application form to all members for the voting/election process. The voting/election process will take place on Survey Monkey and a link will be sent to all WTOHT members.
- There will be 10 organization seats open at the Steering Committee (SC) what happens if more than 10 organizations are interested in becoming a SC member? What happens if there is less than 10 organizations applying?
  - All organizations applicants for the SC seats will be reviewed to confirm they meet the general membership and SC criteria and their information will be shared with WTOHT members for vote/election process. WTOHT membership will be asked to select 10 organizations members out of the number of SC applicants.
  - if there are less than 10 applicants meeting the criteria, WTOHT may invite organizations members to apply for the SC seats for a second round or may decide to proceed with less than 10 organizations seats at the SC

### Q&A

#### Will the current Steering Committee (SC) members stay?

 No, all SC members will go through the vote/election process. For e.g. If a current SC member organization is interested in remaining at the SC, the organization should apply through this new process.

#### •How will the staggered term of 2/3 years at the SC be addressed?

 This will be discussed with the Steering Committee members once the vote/election process is completed.

#### •How will the Chair(s) of the SC be selected?

 The Chair(s) of the SC will be selected once the new SC members are in place as per the updated Terms of reference for the WTOHT Steering Committee
